CONFIDENTIAL TUITION AID APPLICATION

The Florence Wormald/Rita Ward Fund was established with the initial contribution of \$12,000.00 to offer the opportunity of a Christian Secondary Education to students who because of financial considerations may not otherwise have the opportunity. The purpose of the fund is to assist those families with financial need to send their children to a Catholic high school. Since the funds available are limited, we require that each family desiring financial aid complete an application form providing they meet the following criteria.

CRITERIA

1. Student must be from an active, participating family of St. Pius X Parish.
2. This fund is available for students of any grade level who wish to attend or are currently enrolled at Covington Catholic High School, Covington Latin School, Notre Dame Academy, or Villa Madonna Academy.
3. This fund will be awarded based on financial need alone.
4. This fund will be available yearly with priority being given to the current fund holder.
5. This fund is renewable if the student is working to his or her ability and the original qualifications are met.
6. All applications and recipients will be kept strictly confidential.
7. Applications may be requested by contacting the school office or the rectory.
8. Applications must be completed, documented, and returned by March 30.

DIRECTIONS FOR COMPLETING TUITION AID FORM

A parent, step-parent or guardian must fill out the application form (unless the student applicant is living alone.) The person completing the form must also sign it.

Please note that each family is required to provide documents such as income tax forms, pay-stubs, or photocopies of checks. Your form may not be processed without this documentation.

For those questions that require a longer answer please feel free to attach any explanation which may help us better understand your family situation. If you need help in completing this form, contact the Board of Total Catholic Education of St. Pius X Parish by calling the parish rectory or one of the board members.

Answer all questions on this form. (If a question does not apply to your family, put a (0) in the blank.)

When printing information in the blanks on the form, round all income or expenditures to the nearest dollar.

DEFINITION OF EARNED INCOME

Whenever we ask for earned income, we are looking for gross earned income (before taxes and deductions). It does include all money received from a job, business or farm. It does not include money received from rental income, welfare, unemployment, social security or any other source listed under the category "other monthly income" or "miscellaneous income".
